BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE QUOTATION (SCRQ) AND RECOMMENDING THE AWARD OF CONTRACT

WHEREAS, due to the two consecutive failed public biddings for the project Negotiated Procurement for the Supply and Delivery of Machinery and Equipment (EPA 2025), the Bids and Awards Committee (BAC) recommended to the Head of the Procuring Entity the procurement of the project through negotiated procurement, as prescribed in Section 35.5 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184;

WHEREAS, Tarlac State University, through the BAC, in accordance with Section 53 of the IRR, and following the procedures prescribed in Annex H of the IRR for Two Failed Biddings, advertised the Invitation to the Negotiated Procurement for Two-Failed Biddings for the Project Supply and Delivery of Machinery and Equipment (EPA 2025), with an Approved Budget for the Contract (ABC) of ₱ 2,740,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS), the TSU website, and in conspicuous places in Tarlac State University on February 27, 2025;

WHEREAS, in response to the Invitation to the Negotiated Procurement, only one (1) prospective supplier participated in the Pre-Negotiation held at Tarlac State University BAC Conference Room and webcasted via zoom on March 6, 2025;

WHEREAS, after the completion of the negotiations with the prospective supplier, the BAC, through the Secretariat, requested the prospective supplier who attended the pre-negotiation to submit their best quotation, based on the final technical and financial requirements for the project, on or before March 13, 2025 (2:00 P.M.);

WHEREAS, on the specified deadline for the submission of quotations, the BAC received and accepted one (1) quotation from the supplier, Innovative Concept Marketing;

WHEREAS, upon receipt and acceptance of the single quotation, the BAC, with the assistance of the Technical Working Groups (TWGs), opened and checked the quotation, using the non-discretionary "pass/fail" criterion, and found that the quotation contained all the required eligibility, technical, and financial documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, then evaluated the financial quotation of the lone supplier with the result as summarized below:

- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents,
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Quotation as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Innovative Concept Marketing, as the bidder with the Single Calculated and Responsive Quotation (SCRQ), with a bid amount of ₱ 1,990,000.00 for Item No. 1,
- (b) to recommend to the President the Award of Contract for the project, Negotiated Procurement for Two-Failed Biddings for the Project Supply and Delivery of Machinery and Equipment (EPA 2025) for Lot Item No.1 to Innovative Concept Marketing

WHEREAS, the Tarlac State University advertised the Invitation to Bid for the project Negotiated Procurement for Two-Failed Biddings for the Project Supply and Delivery of Machinery and Equipment (EPA 2025), with an Approved Budget for the Contract (ABC) of ₱ 2,740,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in Tarlac State University on February 27, 2025:

WHEREAS, in response to the Invitation to Bid, only One (1) prospective bidder participated in the Pre-Negotiation Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on March 6, 2025;

WHEREAS, in the public bidding held at the TSU BAC Conference Room and webcasted via Zoom on March 13, 2025, at 2:00 P.M., one (1) bidder, namely, Innovative Concept Marketing, participated and tendered a bid for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the first envelope contained in the bid submitted by the lone bidder, using the non-discretionary "pass/fail" criterion, and found that the first envelope of Innovative Concept Marketing, contained all the required documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelope of the lone bidder and found that the envelope of the lone bidder contained the prescribed documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bid of the lone bidder with the result as summarized below:
