WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of College Polo Shirts and P.E. Uniforms (APP 2025 – 1st Quarter), with an Approved Budget for the Contract (ABC) of ₱ 1,800,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on March 11, 2025;

WHEREAS, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on March 19, 2025;

WHEREAS, in the public bidding held at the BAC Conference Room on April 2, 2025, at 2:00 P.M.:

- (a) Two bidders, namely, Woman Fine Clothing Inc., and 1914 Athletics, tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Woman Fine Clothing Inc., to contain all the required documents and were rated "passed", while the first envelope of 1914 Athletics, was found to be ineligible due to the absence of the SLCC,
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelope of Woman Fine Clothing Inc. and found that the envelopes of Woman Fine Clothing Inc. contained the prescribed documents and were rated "passed";
- (d) the BAC resolved to declare Woman Fine Clothing Inc., as the bidder with the Single Calculated Bid (SCB) with a bid amount of ₱ 1,593,500.00,
- (e) the BAC directed the TWGs to proceed with the post-qualification evaluation of the SCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the BAC Conference Room and via zoom on April 11, 2025:

- (a) the TWG for the Legal and Financial Aspects reported that the SCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the SCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the SCB as responsive,

THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- (a) to declare Woman Fine Clothing Inc., as the bidder with the Single Calculated and Responsive Bid (SCRB) with the bid amount of ₱ 1,593,500.00 and,
- (b) to recommend to the President the Award of Contract for the project Supply and Delivery of College Polo Shirts and P.E. Uniforms (APP 2025 – 1st Quarter), to Woman Fine Clothing Inc.

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of College Polo Shirts and P.E. Uniforms (APP 2025 – 1st Quarter), with an Approved Budget for the Contract (ABC) of ₱ 1,800,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on March 11, 2025;

WHEREAS, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on March 19, 2025;

WHEREAS, in the public bidding held at the TSU-BAC Conference Room on April 2, 2025, at 2:00 P.M., Two (2) bidders, namely, Woman Fine Clothing Inc., and 1914 Athletics, participated and tendered their bids for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of Woman Fine Clothing Inc. contained all the required documents and was rated "passed", while the first envelope of 1914 Athletics, was found to be ineligible due to the absence of the SLCC;

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelope of the lone bidder and found that the envelope of the lone bidder contained the prescribed documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bid of the lone bidder with the result as summarized below:


