APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 1,500,000.00

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Large Format Printer/ Eco Solve with an Approved Budget for the Contract (ABC) of ₱ 1,500,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on August 2, 2023;

WHEREAS, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on August 10, 2023;

WHEREAS, in the public bidding held at the Business Center Audio Visual Room (TSU-BC AVR) on August 22, 2023, at 3:00 P.M.:

- (a) Three bidders, namely, Gakken Philippines Inc., ES Print Media Inc., and 5J's Metal Craft General Merchandise tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by Gakken Philippines Inc., and 5J's Metal Craft General Merchandise, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Gakken Philippines Inc., and 5J's Metal Craft General Merchandise to contain all the required documents and were rated "passed" while the first envelope of ES Print Media Inc. was found "ineligible" on the ground that the Class "A" documents submitted to PhilGEPS were not updated.
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelope of Gakken Philippines Inc., and 5J's Metal Craft General Merchandise, and found that the envelopes of the two bidders contained the prescribed documents and were rated "passed".
- (d) the BAC, with the assistance of the TWGs, evaluated the bid of Gakken Philippines Inc.,
- (e) the BAC resolved to declare Gakken Philippines Inc. as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 847,777.00, and
- (f) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the Business Center Audio Visual Room (TSU-BC AVR) on October 12, 2023:

- (b) the TWG for Technical Aspect reported that the LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is nereby RESOLVED.

- (a) to declare Gakken Philippines Inc. as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with the bid price of ₱ 847,777.00 and
- (b) to recommend to the President the Award of Contract for the project Supply and Delivery of Large Format Printer/ Eco Solve to Gakken Philippines Inc.

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Large Format Printer/ Eco Solve with an Approved Budget for the Contract (ABC) of P 1,500,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on August 2, 2023;

WHEREAS, in response to the Invitation to Bid, three (3) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on August 10, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on August 22, 2023, at 3:00 P.M., three (3) bidders, namely, Gakken Philippines Inc., ES Print Media Inc., and 5J's Metal Craft General Merchandise participated and tendered their bids for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by Gakken Philippines Inc., and 5J's Metal Craft General Merchandise, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Gakken Philippines Inc., and 5J's Metal Craft General Merchandise to contain all the required documents and were rated "passed", while the first envelope of ES Print Media Inc. was found to be "ineligible" on the ground that the Class "A" documents submitted to PhilGEPS were not updated;

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelope of Gakken Philippines Inc., and 5J's Metal Craft General Merchandise, and found that the envelopes of the two bidders contained the prescribed documents and were rated "passed";
